2. FIELD INSPECTION, DESIGN, AND RECOMMENDATIONS ARE MADE BY THE ROAD DEPARTMENT/TRUSTEES
3. PERMISSION IS FORMALLY GRANTED TO INSTALL DRIVE/YARD PIPE.
4. OWNER PURCHASED REQUIRED MATERIALS AND COMPLETES ALL WORK NECESSARY TO INSTALL DRIVE/YARD PIPE AS OUTLINED ON PERMIT.
5. **OWNER NOTIFIES ROAD DEPARTMENT/TRUSTEES THAT PIPE INSTALLATION IS COMPLETED** AND READY FOR FINAL INSPECTION BY RETURNING APPLICATION AND PERMIT.

C. PERMIT:

APPLICANT'S STATEMENT: THE APPLICANT AGREES TO INSTALL OR HAVE INSTALLED A DRIVE/YARD PIPE OF THE TYPE AND SIZE HEREIN SPECIFIED AND IN THE LOCATION INDICATED ON THE FIELD INSPECTOR'S SKETCH. 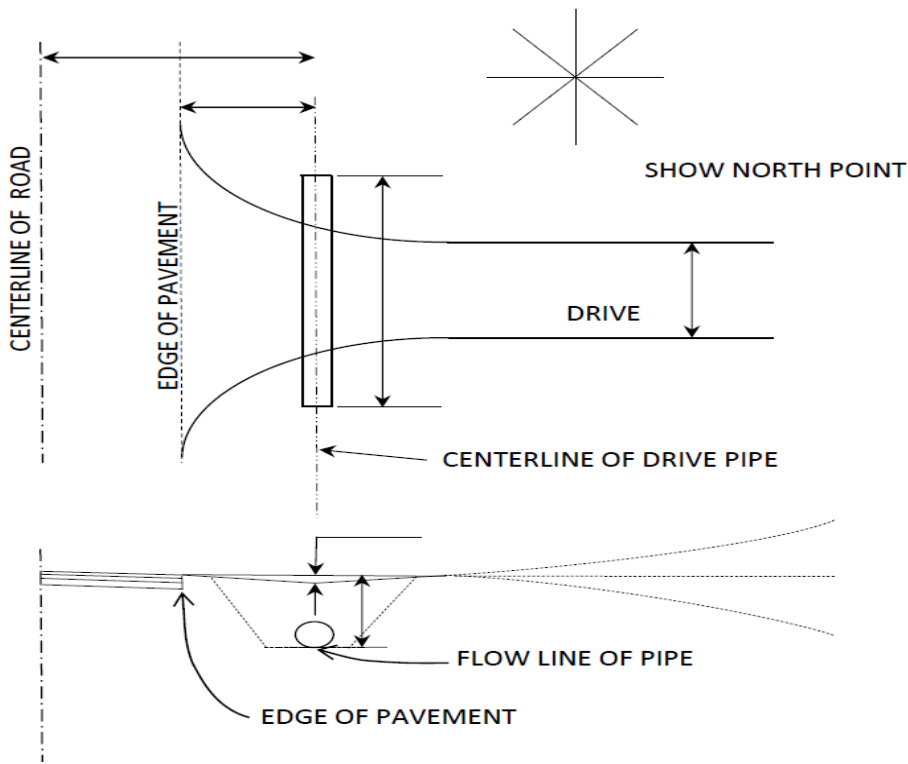

1. EMBED PIPE IN 3" TO 4" OF 304 GRAVEL OR LIMESTONE.
2. THERE SHALL BE NO LARGE STONES, BLOCKS, CURBING OR ANY OTHER PROTRUDING OBSTRUCTION, HIGHER THAN THE ROAD SURFACE AT EACH END OF THE PIPE.
3. LEAVE 1 (ONE) FOOT AT EACH END OF PIPE UNCOVERED.
